He received primary education under the supervision of qualified scholars in religion and linguistics, where he was raised and nurtured under the care of his late father, Sheikh Hamad bin Abdullah Al Thani, who played a prominent and important role in the history of Qatar. His father, Sheikh Hamad bin Abdullah, served as Crown Prince of the State of Qatar from 1935 until his death, may God have mercy on him.

His Excellency Sheikh Mohamed held several positions and had a major and role in the development stages of the State of Qatar; he served as Ambassador of the State of Qatar to Lebanon from 1972 to 1977 and non-resident Ambassador to the Republic of Turkey and the Syrian Arab Republic.

Under Emiri Decree No. (2) of 1978, His Excellency Sheikh Mohamed bin Hamad was appointed as Minister of Education from 1978 to 1989, making great contributions in the development of education, which we can witness to this day. He was also appointed as Advisor to His Highness the Emir Sheikh Khalifa bin Hamad during his tenure.

His Excellency also made great contributions in the development of the economic sector, investment, and business in the State of Qatar, as he was the first to establish a company specialized in tourism and travel in 1968 and the first to establish an integrated private hospital in 2000, inaugurated by His Highness the Father Emir Sheikh Hamad bin Khalifa Al Thani. Sheikh Mohamed bin Hamad also established the Ahli Bank of Qatar with a number of businessmen in 1983.

His Excellency is currently chairing the Board of Directors of the Mohamed bin Hamad Holding Company, which consists of several companies in various fields. His Excellency Sheikh Mohamed, with his insightful vision as a businessman, leads the company's activities with his guidance and skill and directs the path until fulfilling its tasks MBHCC shall continue in his path with knowledge and competence.
